Special Scholarship Policy for the B. Tech Students of AY 2020-21

A. PREAMBLE

Symbiosis is a well-known educational group with a long legacy of offering quality education with a futuristic outlook. Symbiosis Foundation has established India's first Skill Development University at Indore, Madhya Pradesh, called "Symbiosis University of Applied Sciences (SUAS)" in line with the Skill India Mission.

A state-of-the art campus has been established at Indore with specialized laboratories and workshops having skill training equipment, machines and Centre of Excellence. The University has developed a unique skill development model suitable for our country and offers various skill based courses. Our skill development initiative has been immensely successful and more than 1000 students have successfully completed various programs.

As a social responsibility measure, the University declares a special scholarship policy to help meritorious B. Tech aspirants with monetary constraints to obtain quality technical education from Symbiosis.

B. OBJECTIVES OF THE SCHEME

- To provide educational opportunities to meritorious students from all sections of society.
- To promote technical education amongst students.

C. ELIGIBILITY CRITERIA

- 1. The Scholarship scheme will be applicable to the students taking admission in the first year of B. Tech course of SUAS in CSIT, Mechanical and Mechatronics branch only.
- 2. Marks obtained by the students in his/her 12th Standard or equivalent examination should be above 60% in aggregate. He /She will avail the

scholarship as per the bracket notified and their eligibility criteria (refer *Annexure A*).

- Students applying for admission under this scheme shall be required to fulfil eligibility conditions as prescribed by UGC/AICTE/The University/DTE/ any other relevant statutory body or authority at State/ National Level.
- 4. It would be applicable for direct admission (not for lateral entry) in academic year 2020-21.

D. SCHEME OF SCHOLARSHIP

The amount of scholarship granted to the students will depend upon their performance in 12th Standard or equivalent examination. The amount of scholarship granted to the students will be as per the scheme given in **Annexure A**.

E. CONDITIONS FOR SCHOLARSHIP

- This scheme is applicable only for Academic Year 2020-21 purely on merit basis.
- This scheme is applicable only for students who are taking admission to First Year of Academic Year Session 2020-21. Scheme is not applicable to students for Lateral entry to the Program.
- Student availing scholarship under this scheme will not be eligible for any other scholarship of the University.
- Management reserves its right to decide the quota for Admission.
- This scheme will be applicable for higher academic years to only such students who were admitted under the scheme in academic year 2020-21. Candidates meeting the eligibility criteria for scholarship must make a separate application for Scholarship continuation to the University from their second year onwards.
- The management reserves its right to terminate this scheme at any stage.

F. CONTINUATION OF SCHOLARSHIP

A candidate will be eligible for continuation of scholarship in the subsequent years only if all the conditions are fulfilled as mentioned below:

- 1. Students should clear all the subjects of the preceding semesters with a minimum SGPA and CGPA of 7.5 for all scholarship brackets.
- Students only those who are declared as admitted to next Academic Year of their program without any backlog shall be eligible for the scheme.
- 3. There should be no disciplinary case against the student inside or outside the University campus.
- 4. Student must have 80% attendance or above.
- 5. Student should not have discontinued from education at any time in the University.
- 6. Once the student loses the scholarship for any one of the reasons mentioned above, the scholarship shall not be provided again in subsequent years. In such cases, student is required to pay the full academic fee for all subsequent years. It may be noted that no representation of any kind will be entertained and students will unconditionally abide by the University scholarship norms.
- There shall be no upward change in the bracket of scholarship in subsequent years and bracket in which scholarship is awarded in AY 2020-21 shall continue subject to fulfilment of conditions mentioned above.

G. APPLICATION PROCESS

- Interested candidates are required to fill the SUAS Scholarship application form (*Annexure B*) and submit it with his/her duly signed Scholarship Undertaking (*Annexure-C*) at the Registrar Office as per the notified date and time.
- 2. The forms of Applications are available at Registrar Office and can also be downloaded from the University website www.suas.ac.in.
- 3. For continuation of scholarship students need to apply before commencement of new Academic Year with their result of previous academic year by due date, failing which the scholarship will be forfeited.

- 1. Last Qualifying Exam Mark sheet
- 2. Duly Filled Scholarship Form
- 3. Duly signed Scholarship Undertaking

I. PROCESS BY UNIVERSITY ON RECEIVED FORMS

- The Applications under this scheme will be submitted in Registrar office.
- The application will be scrutinized by the committee constituted by Honourable Vice-Chancellor of the University.
- The committee will scrutinize the applications on the basis of Percentage of marks of the student in his/her 12th Standard Examination, Validity of Examination board etc.
- The decision of the University regarding the scheme will be final.
