The constitution, Powers and Functions of Governing Body will be as per Section S.5A of the Statute.

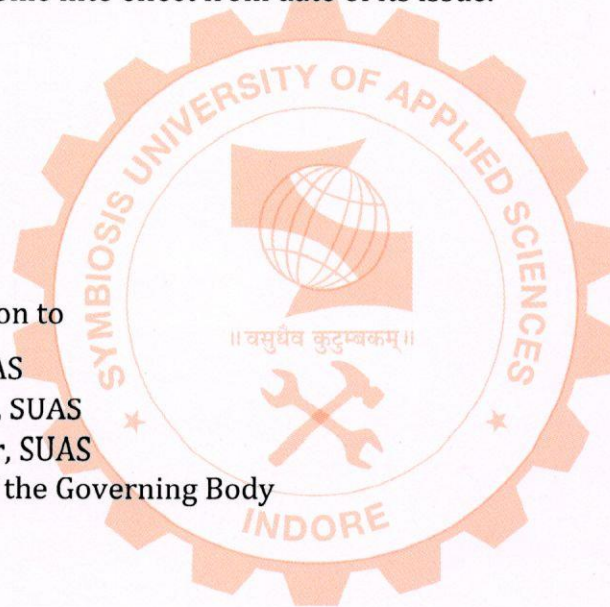
